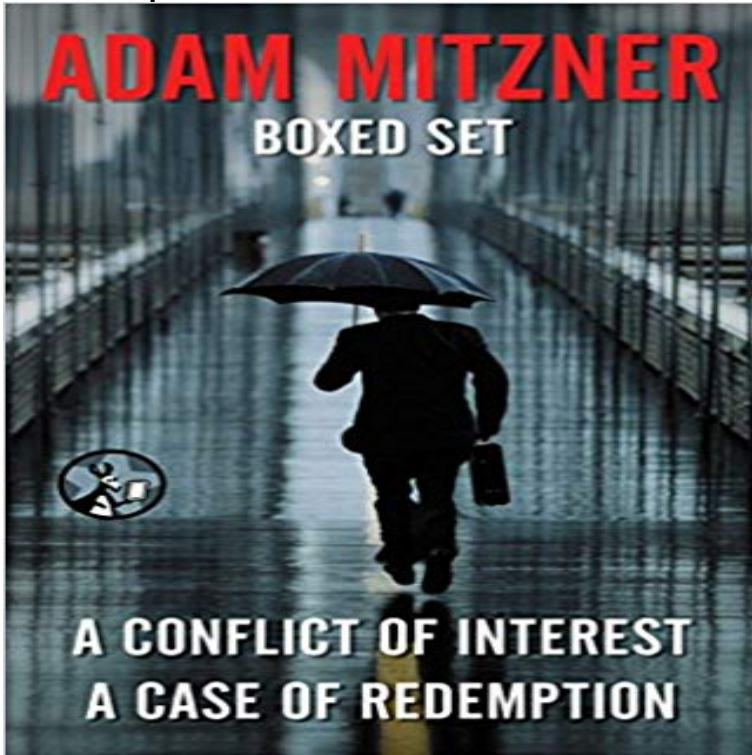


Adam Mitzner Boxed Set: A Conflict of Interest and A Case of Redemption
